


**DETERMINATION OF THE DIRECTOR OF ADMINISTRATION AND

Under the authority delegated to me by the Secretary of Defense, I have determined that the following information is exempt from disclosure under Exemption 3 of the Freedom of Information Act (5 U.S.C. § 552(b)(3)) because it meets the requirements for exemption under 10 U.S.C. § 130e:

Department of Defense information concerning Explosive Safety  
Quantity Distance Arcs and explosive handling zones at Naval  
Magazine Indian Island, Port Hadlock, WA.

**STATEMENT OF THE BASIS FOR THE DETERMINATION BY  
THE DIRECTOR OF ADMINISTRATION AND MANAGEMENT**

In accordance with 10 U.S.C. § 130e, I reviewed the information provided to me by the Department of the Navy concerning Explosive Safety Quantity Distance Arcs and explosive handling zones at Naval Magazine Indian Island, Port Hadlock, WA, and determined that it qualifies as Department of Defense critical infrastructure information (CISI). As defined by 10 U.S.C. § 130e, CISI includes:

“...sensitive but unclassified information that, if disclosed, would reveal vulnerabilities in Department of Defense critical infrastructure that, if exploited, would likely result in the significant disruption, destruction, or damage of or to Department of Defense operations, property, or facilities, including information regarding the securing and safeguarding of explosives, hazardous chemicals, or pipelines, related to critical infrastructure or protected systems owned or operated by or on behalf of the Department of Defense, including vulnerability assessments prepared by or on behalf of the Department of Defense, explosives safety information (including storage and handling), and other site-specific information on or relating to installation security.”

This information meets this definition of CISI because it is information concerning the security and storage of weapons, to include details of Explosive Safety Quantity Distance Arcs, at Naval Magazine Indian Island, and if the information were released to the public it would likely enable an adversary to identify and possibly exploit vulnerabilities of the weapons storage facilities at Naval Magazine Indian Island and cause significant disruption, destruction, or damage to these facilities and thereby cause further damage to U.S. Navy operations that rely on the security of these weapons.

I also considered the public interest in the disclosure of this information; specifically, the interest that the residents of Port Townsend, WA, have in the affects of a serious adverse event at Indian Island as detailed in the documents listed in Table 1, below, and have weighed this against the harm that would likely result if it were to be disclosed as detailed in the documents listed in Table 2, below. The documents listed in Table 1 are contained in the record of the litigation involving this request except for one additional document: a letter from the Mayor of the City of Port Townsend. The documents listed in Table 2 are all contained in the record of the litigation involving this request. I have considered the relevant material in each of these documents.

The public interest in the disclosure is not insignificant in this instance; however, the harm that would likely result from disclosure is very serious and much more significant. Therefore, the public interest consideration in the disclosure of this information does not outweigh the preventing the disclosure of the information.
